POST (Police Officer Standards and Training Board) – Many of the police reform bills passed by the Minnesota Legislature will go to the POST Board for development of policies and practices for implementation. Our own Liz Richards is on the POST Board.

This past week, the POST Board passed the following:

- POST to develop a model policy, in partnership with community advisory groups and following best practices, on law enforcement response to 1st Amendment protests. Each law enforcement agency must adopt the policy.
- Created an ad hoc committee to determine the board's scope of authority and make recommendations for accountability when officers and/or agencies fail to follow policy.
- Start process to create a rule prohibiting law enforcement officers from associating with white supremacy hate groups.
